## ORDER NO. R - 1 / 2024

Whereas, it is considered necessary by the High Court in the public interest that Sri.Sudhish T.A., Assistant Registrar Hr. Gr., High Court and Sri. Sudheesh P.M., Court Keeper (Higher Grade), High Court should be suspended from service pending enquiry and disciplinary action, in the matter relating to derogatory content and criticism against the Government in the stage show performed at the High Court Auditorium during the Republic Day Celebrations, 2024.

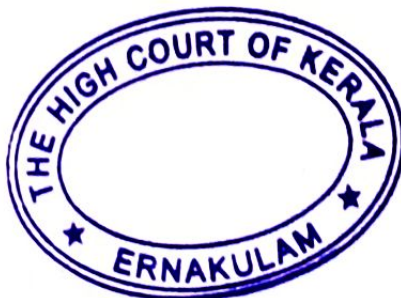
The Honourable the Chief Justice, vide reference cited 3<sup>rd</sup>, has ordered that Sri.Sudhish T.A., Assistant Registrar Hr. Gr., High Court and Sri. Sudheesh P.M., Court Keeper (Higher Grade), High Court be placed under suspension. The suspension shall take effect with immediate effect.

They shall return Government properties held by them, if any, including the Identity Card issued to them.

They will be paid during the period of suspension the subsistence allowance and other allowances admissible as per the relevant rules in practice during the period of suspension.

The Honourable the Chief Justice further directed to conduct a detailed enquiry by Registrar (Vigilance) as to the above said incident and to submit a report at the earliest. Registrar (Administration) is directed to furnish a detailed explanation as to the circumstances in which the above said incident took place.
