Sub:- Request for registration of First Information Report under section 3, 5, 6 and 9 of the Official Secrets Act, 1923 and under section 61, 147, 148, 152, 197, 353 of the Bharatiya Nyay Sanhita, 2023 against Shri. Rahul Gandhi, Member of Parliament, Lok Sabha and Leader of opposition Lok Sabha, Publisher M/s Penguin Random House India and unknown others involved in this very serious criminal offences related to unpublished book "FOUR STARTS OF DESTINY" with regard to disclosing official secrets and committing very serious offences which is directly threat to national security and integrity of India also disclosing secret information which is not in public domain, due to the disclosure of such information it has benefitted the Enemies of India and commission of such a criminal offence is direct threat to national security of India.

1) With reference to the above subject, I would like to request the Station House officer and Inspector of Police, Parliament Street Police Station of Delhi

Police to kindly immediately take cognizance of this very serious criminal offence committed by Shri. Rahul Gandhi by openly disclosing inside the Parliament Building Compound on 4th February., by Quoting an Unpublished Book "Four Stars of Destiny" written by General and Chief of Army Staff Shri. Manoj Mukund Naravane.

2) Shri. Rahul Gandhi has on 04/02/2026 inside the Parliament Compound committed this very serious offence by "**openly reading Official Secrets with regard to Military Decision Making Process of Indian Army about the incoming Chinese Troops / Chinese Tanks on Kailash Ridge in Union Territory of Ladakh**", since the book in question "**Four Stars of Destiny**" is still not cleared by the Ministry of Defence for Commercial Publication and the contents of the Book are still under review even as on 08/02/2026.

3) When this being the case Shri. Rahul Gandhi, Member of Parliament Lok Sabha and Leader of Opposition, Lok Sabha on 04/02/2026 has wilfully with criminal conspiracy, committed this serious criminal offence by reading out the contents (as mentioned in this Book "Four Stars of Destiny"), certain highly classified Military Secrets with regard to Decision Making Process of Chain of Command of Indian Army in such sensitive and dangerous situations as Authored by General Manoj Mukund Naravane.

4) Shri. Rahul Gandhi has openly showcased this still officially unpublished book "FOUR STARS OF DESTINY" Book and Shri. Rahul Gandhi has openly read the "official secrets / military secrets and Military Operational Decision Making of Indian Army and Chain of Command", contents of this book which is still not officially published in front of all the National Media and News Agencies like ANI, PTI, IANS and several other national Television Channels.

5) Shri. Rahul Gandhi himself in the beginning of the video says that "I have been told not to quote this book"., then knowingly well with criminal motive he goes on to read the classified official secrets of the country and Indian Army inside the book and starts speaking about various secrets and classified operational decision making of Indian Defence and Military Establishment.

6) Copy of the Footage, Media News Published visuals are enclosed herewith to be considered as evidence for this Case for the purpose of Registration of the First Information Report.

7) Further Shri. Rahul Gandhi, goes on to once again disclose official secrets amounting to criminal offence directly putting the National Security of India in Threat and state that and quote that Shri. Rajnath Singh Ji, Hon'ble Defence Minister of India told that if "Chinese forces come inside, without asking not to fire upon them".

8) Further Shri. Rahul Gandhi, **goes on to claim that Chinese Tanks had already entered inside India.**

9) Shri. Rahul Gandhi also further went on and said that., General Manoj Mukund Naravane has written in the book that **“ I felt really alone and I was abandoned by the Entire Establishment”**.

10) **Every word which is uttered by Shri. Rahul Gandhi is clearly quoted and uttered with criminal conspiracy with regard to disclose official secrets about the operational decision making of Indian Army in the context of Military Situations, which is highly classified information and an official secret.**

11) **The statements of Shri. Rahul Gandhi, Member of Parliament Lok Sabha is clearly and directly a Threat to Integrity and National Security of India, it is lowering the morale of the Indian Army and Defence forces as he is illegally quoting from an Unpublished Book “Four Stars of Destiny” by General Manoj Mukund Naravane. Since even till date the Ministry of Defence has not accorded clearance for the publication of this Book.**

12) **Without the Clear involvement of the Publisher M/s Penguin Random House India and unknown others involved how a Printed Version of this Book which is clearly visible in the Video Footage / Visuals is provided to / acquired by Shri. Rahul Gandhi is very serious criminal offence.**

13) **It is very important for Delhi Police to immediately arrest all the accused persons involved in this serious criminal offence as how such “TOP SECRET” Defence Secrets are being illegally published in the form of such books and how such illegally published books which are not even cleared by the Ministry of Defence formally have reached the hands of Shri. Rahul Gandhi, Member of Parliament and who in turn is using this illegal book for his own political criminal motive and agenda to create direct instability to National Security apparatus of India and lower the morale of the Defence Forces to help the enemies of India directly by his open Acts of committing this very serious criminal offence.**

Rahul Gandhi, Member of Parliament, Lok Sabha and Leader of opposition Lok Sabha, Publisher M/s Penguin Random House India and unknown others involved in this very serious criminal offences related to unpublished book "FOUR STARTS OF DESTINY" with regard to disclosing official secrets and committing very serious offences which is directly threat to national security and integrity of India also disclosing secret information which is not in public domain, due to the disclosure of such information it has benefitted the Enemies of India and commission of such a criminal offence is direct threat to national security of India.
