## Subject.: Declaration of the Result/NTA Scores for the Joint Entrance Examination [JEE (Main) - 2026] of Paper 1 (B.E. / B.Tech.) – reg.

The Department of Higher Education, Ministry of Education, Government of India has entrusted the responsibility of conducting the Joint Entrance Examination (Main) to the NTA from 2019 onwards.

For Academic Session 2026-27, NTA conducted the JEE (Main) – 2026 in two Sessions i.e. Session 1 (January 2026) and Session 2 (April 2026) as per the details given below:

Paper 1 (B.E. / B.Tech.) was completely conducted in the **CBT (Computer-Based Test)** mode. JEE (Main) 2026 Session-1 Examination was conducted in ten (10) shifts and in Session-2 (April 2026), it was conducted in nine (09) shifts.

The Examination was held in **13 languages (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu)**.

The JEE (Main) – 2026 Session 2 was conducted at 584 unique examination centres in 319 Cities (including 15 cities outside India in **Manama, Doha City, Muscat, Riyadh, Sharjah, Singapore, Kuwait, Kuala Lumpur, Kathmandu, Abu Dhabi, West Java, Washington, Lagos, Munich and Dammam**).

**Various measures were adopted by NTA for smooth conduct and monitoring of examinations as under:**

❖ NTA made elaborate arrangements at various levels and ensured smooth conduct of the examination through robust planning, use of technology, and close coordination with Central and State authorities.

❖ The online application portal was developed for inviting applications for JEE (Main) 2026 with **several new features to enhance accuracy, security and ease of use which includes the following:**

- **AI-Based face comparison.**
- **OTP-Based Aadhaar e-KYC authentication.**
- **Live Photograph comparison with the Aadhaar/ Digi Locker photograph.**
- **Verification of the uploaded photograph against the live photograph.**
- **Automatic fetching of PwD/PwBD details from the UDID portal.**
- **Option of City Choice to candidates was restricted only to states of their present and permanent addresses.**
- **Centralized Social Media monitoring system.**
- **Mandatory Aadhaar Authentication of candidates during all the shifts in JEE (Main)-2026 Session-2.**

❖ **Pre-examination centre audit for all JEE (Main) 2026 examination centres was conducted by the DLCC prior to the commencement of Session 1. Additionally, a third-party audit agency carried out audits for certain identified centres before the start of Session 2.**

❖ **Special emphasis was made on the random deployment of exam functionaries in all centres. 304 City Coordinator, 630 Observers and representative of certain Government Cyber Security Agencies were deputed for examination duties in various cities and centres.**

❖ For the centres outside India, close coordination was done with the Embassy of India/ High Commission of India in those Countries. 38 Special Observers from Indian Embassies were deputed for examination duties in various centres outside India. In view of emerging challenges, NTA undertook the several proactive measures:

- Candidates affected by disruptions in certain Middle Eastern regions were facilitated through rescheduling and relocation of centres with support from Indian Missions abroad.
- ❖ NTA coordinated with the CBSE and ensured no overlap between JEE (Main) and Class XII Board examinations by aligning schedules and enabling candidate-specific adjustments.
- ❖ Orientation training programme was conducted for all the examination functionaries in online mode for three consecutive days before start of the examination. A total of approximately 900 exam functionaries attended the orientation training session.
- ❖ A Central Control Room was opened at NTA to monitor and facilitate the smooth conduct of the Examination on the ground. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi.
- ❖ Live CCTV Surveillance with analytics was performed for all examination centres to curb malpractices in the examination. Recording of CCTV was used for post examination analysis for identifying act of malpractices.
- ❖ The examination centres were also monitored using AI-based Video Analytics and Virtual Observers.
- ❖ Jammers were installed in all the Centres to prevent unfair practices by the candidates during the examination through mobile or any other electronic device. The latest 5G Jammers were installed at all examination Centres.
- ❖ The candidate's particulars including Category and Person with Benchmark Disability (PwBD) have been indicated as mentioned by the candidate in the online Application Form.
- ❖ The PwD/ PwBD candidates were allotted to a PwD/PwBD-friendly test Centre and organizational support was given to those candidates.
- ❖ The proof of identity as mentioned by the candidate in online application form was included in the admit card of the respective candidate for verification at the examination centres.

- ❖ Apart from the biometric attendance and frisking at entry, candidates were frisked, and biometric attendance was taken again on entry from the bio-break/toilets break.
- ❖ Bio-breaks were not during the first hour and the last half an hour before the end of the examination.
- ❖ To make the candidates and their parents aware of the rules and regulations of the examination the "**Important Advisory and Instructions to the candidates for JEE (Main) 2026**" were included in the Admit Card.
- ❖ **Unfair Means.** In JEE (Main) 2026 Session 1, the NTA Scores of 54 candidates were not declared as they were found to have indulged in unfair means practices. During Session 2, a total of 57 candidates were similarly found to be involved in Unfair means including forgery of any documents related to examination, possession of mobile phone/ written chit and consequently, their results have not been declared. In addition to this, the results of 56 candidates have been withheld due to discrepancies in their documents, photographs, biometric details, unfair means or other personal information for identity verification etc.
- ❖ To ensure transparency and enabling candidates to review the questions asked during the examination, **NTA uploaded the Question Papers for all the shifts of JEE (Main) 2026 Session 2 in NTA official website after completion of examination on 09 April 2026.**
- ❖ In order to make the examination system transparent, the **Question Paper and recorded responses along with the provisional Answer Key were displayed on the website for verification by candidates.** After verification by the Subject Experts, the Revised Answer Keys were published on the website.
- ❖ The **NTA Scores for Paper 2A (B.Arch.) and 2B (B. Planning)** for the JEE (Main) – 2026 Session 2 will be issued separately.

NTA thanks all the Central Government Departments, Embassies of India in countries where examinations were conducted, State and District authorities and various exam functionaries for all the support extended for the successful conduct of the prestigious JEE (Main) 2026 Session 2. NTA wishes the very best to the students appearing for JEE (Advanced) 2026.
